TRAINING RECOGNITION

PROGRAM OUTLINE

Blended Learning (also known as hybrid learning) is a teaching method that integrates technology-based online learning with traditional instructor-led face-to-face classroom activities and practical tasks.

FACE-TO-FACE TRAINING

The course is delivered in one 5-day block.

To ensure the quality of the training, the number of participants in each course is limited to 8.

Or

VIRTUAL CLASS ROOM (online with a live trainer). Four-day block plus an additional single day.

A virtual classroom is a digital platform designed for learning that employs a delivery format such as Zoom. Here, a live trainer facilitates online training sessions, focusing on critical course content and guiding students on how to navigate through the program. This medium enables real-time engagement through audio and video communication, allowing trainers to interact with their students as they participate in learning and assessment activities. 9 am to 3 pm

ONLINE LEARNING

Online learning is completed in and out of the course, where students research, prepare and submit their assessments via the Learning Management System (LMS). Students will research, develop procedures, and employ templates with the available resources based on genuine work performances for evaluation purposes. Students will complete interactive online quizzes corresponding to the covered subjects. To research the answers, students can refer to the course training materials, notes & other relevant references.

PRACTICAL TASKS

Students' practical tasks require them to develop various documents, service reports, and outcomes found in the industry. Tasks will be performed in the course in front of the trainer/assessor and in the workplace. The training is structured logically to enable a step-by-step learning process. The activities are presented clearly. They are directly linked to the course and industry information, allowing assessors to ascertain that students can competently apply their knowledge and skills. The course duration is flexible, with students having up to 12 months to complete workplace tasks.

To assist students in their learning journey, Axiom Compliance Learning offers the expertise of highly skilled and motivated trainers and assessors with current industry experience. These professionals create an interactive, engaging, and supportive learning environment to facilitate learning. Some of the required work performance evidence to complete this course is as follows

Twenty fire hose reel inspections across a minimum of five different sites, including at least five inspections of hose reels installed in recess cupboards or cabinet

Fifteen Hydrant systems across a minimum of 10 sites

Ten fire extinguishers, including at least one of each of the following- water, dry chemical, carbon dioxide, wet chemicals and foam.

Five fire blankets across 2 separate buildings



Twenty fire and smoke doors over two different sites

Thirty single-point emergency light fittings or exit signs over five different sites

Please note that some work performance tasks are covered in the face-to-face training.

A traineeship is a structured learning program in which a trainee or apprentice undertakes paid employment in a vocation or trade to achieve a recognised qualification. The employer provides training and work relevant to the trade or declared vocation. Training providers deliver off-the-job training and issue relevant qualifications.

CPP20521 Certificate II in Fire Protection Inspection and Testing requires a traineeship training plan. This can be achieved with an existing or new employee.
